Independent Contractor Agreement for Facility Master Planning Services with King Consulting

SUPERINTENDENT REPORT

Dave Scroggins presented information to the Board including:

- 2021-22 Projected Enrollment: <u>170</u> students (66 LES; 104 MH).
- <u>CDPH/Mask update</u>: Dave has met with the Superintendents and Dr. Williams to discuss the latest guidance for reopening and will be sending a letter to our parents tomorrow. As of today:
 - o We will be wearing masks indoors.

- o Social distancing requirements have been lifted.
- o There will be no quarantining required if the individuals were wearing masks.
- We will not be doing any Distance Learning; however districts are required to offer an Independent Study option which must include daily synchronous interaction. We have one family requesting this and we have agreements in place with Buckeye to accept them on an Interdistrict Transfer into their Independent Study program.
- Rules about Covid testing are ambiguous; nurse Patty Knobelauch has an upcoming meeting with district nurses to clarify. Scot inquired if there is some way for us to facilitate testing for our families? It may be possible the high school did it last year for sports.
- Letter from Planning Commission regarding the Carson Creek Specific Plan Amendment public hearing scheduled for August 10, 2021 at 9:00am.
