Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

- During the 2020-2021 school year the staff met to review current levels of student achievement and identify students who needed
 additional support. The final meeting that included input for our new LCAP also included suggestions to meet the needs of students
 who will be returning from a year of distance learning. The staff also requested additional counseling days. Currently the district
 employs a counselor one day per week. That was a reduction this year. Moving forward the plan is to increase counseling to two
 days per week, one day a week at each school.
- Following the same input format for changes to our current LCAP goals, the Site Council/Parent Advisory Committee met to review goals and offer suggestions for new goals. Their input was also incorporated into our proposed goals. Additionally, suggestions were made to include opportunities for after school enrichment opportunities for students in all grades.
- Parent information was gathered from the annual spring survey which was open from April 16 April 26, 2021.
- The Parent Teacher Club (PTC) provided feedback to the principal at monthly meetings throughout the school year.
- Students in grades 4-6 at Miller's Hill School provided feedback regarding school climate, the academic program, sports and PE through the annual school survey. All students took the survey which is available in April each year. Students completed the survey the week of April 12-16, 2021.

• Funds will be principally directed to serve students that include low-income, English Learners, and foster youth. Individual and small group interventions will target under-performing students based on local assessments, diagnostic tests, and teacher observation. The paraeducator, under the direction of the classroom teacher will provide support in phonics (SIPPS), reading fluency development and comprehension. This research-based instructional strategy of targeted, instruction scaffolding in smaller groups provides the most effective intervention for our at-risk students.

Funds will also be allocated for an additional day of counseling. The extra day will allow students to have access to a counselor one
day per week instead of every other week as we have now. Students are referred to counseling by staff members or family
members.

- A schedule of opportunities for remediation and enrichment will be available to parents at the beginning of the 2021-2022 school
 year.
- Counseling will be based on referrals from staff members and/or requests from parents/guardians.

- Students who are identified as needing supplemental instruction in either English Language Arts or Math will be invited to participate in after school tutoring by a member of the district teaching staff.
- Students will also be targeting for intervention during school hours based on specific needs. Paraeducators will provide this additional support under the direction of the child's teacher.
- Counseling will be based on referrals from staff members and/or requests from parents/guardians.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
